The following **types of sessions** will be offered at our 2021 event:

- 25-minute session (“Ted Talk” style session)
- 50-minute session (Presentation & Discussion)
- 3-hour or 6-hour session (Workshop)

As part of your submission, please indicate the type of session for which you are submitting.

SESSION LEARNING LEVELS

For attendees to have the most beneficial conference experience, it is critical that presentations are delivered at the learning level at which they were described, i.e., **beginner, intermediary, or advanced**. Please pay special attention to the learning level you have described in your submission abstract and commit to designing your presentation to fit the description.

Try to stay away from academic/theoretical learning objectives. Make sure your submission includes actionable takeaways; practical guidance that attendees can immediately apply when they are back in the office. If possible, use real world examples and case studies.

Our subject matter experts look for submissions with clear and concise learning objectives that align with the abstract. Make sure your submission is strictly educational and not a commercial or sales pitch, our subject matter experts quickly eliminate anything 'sales pitchy' or vendor specific. We also received a lot of very similar submissions, and with a limited number of accepted sessions, the subject matter experts must pick the sessions and the presenters they think best address the topic. Be original and make your proposal stand out! Very few sessions with a beginner learning level are selected. The majority of accepted submissions will be intermediate to advanced learning levels.

SPEAKER PERKS

Speakers who are selected will receive the following benefits:

- Complimentary conference registration* (complimentary registration is given to 1 speaker per session only)
- CPE hour (s) for the session they present at.
- One additional complimentary registration, to an additional person (you must provide relevant contact details, for us to send the complementary registration invitation)

* Complimentary registration is not transferable or able to be used as a credit. Registration for the pre-workshops are not included with complimentary conference registration. Any speaker who meets the criteria of a Top-Rated Speaker will receive special formal recognition from ISACA Kingston Chapter, and will be named as a Top-Rated Speaker on the ISACA Kingston Chapter conference website. For Top speakers that are also ISACA members, their name will be submitted to the ISACA HQ as a recommended addition to their speaker repository.
